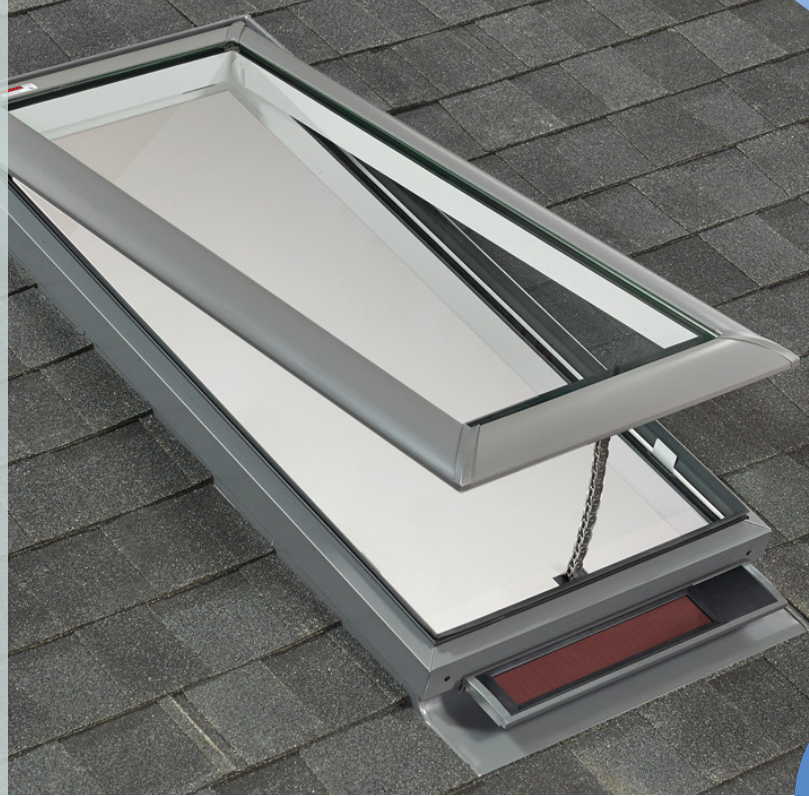

## Guide to receive your tax credit

### Background

On October 3, 2008, President George W. Bush signed the Emergency Stabilization Act into law. Following that, President Barack Obama signed the American Recovery and Reinvestment Act of 2009 into law on February 17, 2009. And lastly on August 16, 2022, President Joe Biden signed into law the Inflation Reduction Act of 2022.

The combined effect of these laws provides up to a **30% tax credit on both the purchase and installation** of qualifying products in renewable technologies such as; solar electric property, electric vehicles, solar panels, heat pumps, and other energy-efficient home improvements.

### What do I need to do?

#### When the product is installed:

- Keep your receipts for total price paid (**invoice from contractor for product and installation**) of the qualifying VELUX products.
- Attach receipts to a completed **Manufacturers Certification Statement<sup>1</sup>** and keep for your records (see reverse side).



<sup>1</sup> IRS Notice 2009-41 suggests the taxpayer is not required to attach this certification statement to their tax return. However, the taxpayer should retain this certification statement as part of their tax records.

When purchased and installed between January 1, 2022 through December 31, 2034, certain VELUX products qualify for the tax credit under "Solar Electric Property" expenditures. These products include VELUX Solar Powered "Fresh Air" Skylights and other eligible VELUX Skylights with solar-powered shades, as well as VELUX Residential Rigid Sun Tunnel\* Skylights installed with the Solar Night Light.

**2022–2032: Save 30% with the Federal tax credit**

**2033: Save 26% with the Federal tax credit**

**2034: Save 22% with the Federal tax credit**

#### When it is tax time:

- Fill out the **IRS Residential Energy Efficient Property Credit tax form 5695** (under "Qualified solar electric property cost").
- Submit it with your taxes. Enter this tax credit off of **form 5695** on your **IRS tax form 1040**.

# Manufacturer's certification statement

For Eligible Residential Energy Efficient Property as covered under Section 25D of the Internal Revenue Code

VELUX America LLC solar electric property

This Manufacturer's Certification Statement can be relied upon by a taxpayer for verification that certain VELUX products eligible for the tax credits identified in the Inflation Reduction Act of 2022. The IRS has published tax-related interpretations for "Residential Energy Efficient Property" in IRS Notice 2009-41. The IRS requires the manufacturer be identified: **VELUX America LLC, P.O. Box 5001, Greenwood, SC 29648** as the manufacturer of VELUX products covered by this certification.

Following the IRS guidelines and under advisement by our tax advisors, VELUX has determined the following products are eligible as Residential Energy Efficient Property and qualify for the credit allowed under Internal Revenue Code Section 25D (VELUX Solar Electric Product Cost and Installation amount should be listed as Qualified Solar Electric Property Cost on the IRS form 5695. For all other FORM filing questions, please consult your tax advisor), Section (a) (1) for the VELUX Solar Power "Fresh Air" Skylight, Solar Battery Lightblock Shade, Solar Blackout Shade, and Solar Light Filtering Shade plus installation costs when purchased and installed from January 1, 2022 through December 31, 2034 in the US.


